2 SOCIAL JUSTICE ADDRESSING SYSTEMIC INEQUALITIES COMMUNITY PSYCHOLOGY IS DEEPLY ROOTED IN SOCIAL JUSTICE PRINCIPLES IT RECOGNIZES THAT SOCIETAL STRUCTURES AND INEQUALITIES SIGNIFICANTLY IMPACT MENTAL HEALTH AND WELLBEING DISCRIMINATION BASED ON RACE ETHNICITY GENDER SEXUAL ORIENTATION SOCIOECONOMIC STATUS AND DISABILITY CREATES SIGNIFICANT BARRIERS TO ACCESS AND OPPORTUNITY PERPETUATING CYCLES OF DISADVANTAGE

EMPOWERMENT IS A CENTRAL TENET OF COMMUNITY PSYCHOLOGY IT EMPHASIZES THE IMPORTANCE OF FOSTERING SELFDETERMINATION AND AGENCY WITHIN COMMUNITIES THIS INVOLVES ACTIVELY INVOLVING COMMUNITY MEMBERS IN ALL STAGES OF THE RESEARCH AND INTERVENTION PROCESS FROM NEEDS ASSESSMENT TO PROGRAM DESIGN IMPLEMENTATION AND EVALUATION PARTICIPATORY ACTION RESEARCH PAR IS A KEY METHODOLOGY IN THIS APPROACH

COMMUNITY PSYCHOLOGY EMPHASIZES PREVENTION AND PROMOTION RATHER THAN SOLELY FOCUSING ON REMEDIATION IT SEEKS TO IDENTIFY RISK FACTORS AND PROTECTIVE FACTORS THAT INFLUENCE INDIVIDUAL AND COMMUNITY WELLBEING THIS PROACTIVE APPROACH IS COSTEFFECTIVE AND AIMS TO ENHANCE OVERALL COMMUNITY RESILIENCE
